

Casting Call: The Game – Limited Warranty

Effective Date: January 1, 2025

Warranty Coverage:

Whitestone Acquisitions LLC (“Company”) warrants to the original purchaser (“Customer”) that the physical components of *Casting Call: The Game, Horror Movie Expansion Pack, and Adults Only Expansion Pack* (the “Product”), including the deck of playing cards, will be free from defects in materials and workmanship under normal use for a period of **90 days** from the date of delivery. This warranty is provided in compliance with the **California Song-Beverly Consumer Warranty Act** and other applicable California laws.

Warranty Period Commencement:

Per California Civil Code § 1793.01, the warranty period begins on the date the Product is delivered to the Customer.

Customer Rights:

If a defect arises during the warranty period, the Customer has the right to have the defective Product replaced. The warranty period will be extended for the number of days the Product has been out of the Customer’s possession for warranty claims. If a defect exists within the warranty period, the warranty will not expire until the defect has been remedied.

Warranty Service:

To obtain warranty service, the Customer must contact Whitestone Acquisitions’ customer support at game@cinema175.com to receive instructions on returning the defective Product. The Company will, at its discretion, replace the defective deck of cards at no charge. If the Company cannot replace the Product after a reasonable number of attempts, the Customer may receive a refund, subject to a deduction for usage.

Exclusions:

This warranty does not cover:

- Damage caused by normal wear and tear, including bending, creasing, or fraying of cards.
- Damage caused by misuse, spills, or exposure to moisture.
- Damage resulting from unauthorized modifications or attempts to alter the Product.
- Lost or stolen components.

Implied Warranties:

Any implied warranties, including the **implied warranties of merchantability and fitness for a particular purpose**, are limited to the duration of the express warranty. Some states, including

California, do not allow limitations on how long an implied warranty lasts, so this limitation may not apply to you.

Limitation of Liability:

The Company’s liability is limited to the replacement of the defective Product. The Company shall not be liable for **any incidental or consequential damages**, including lost enjoyment or time. Some states, including California, do not allow the exclusion or limitation of incidental or consequential damages, so this limitation may not apply to you.

Legal Rights:

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
